We refer to your request for clarification/confirmation of the news article entitled "Emperador to withhold 40% of capex" posted in The Manila Times (Online Edition) on August 21, 2020, which reported in part that:

"Listed Emperador Inc. announced on Thursday that it would hold back about 40 percent of its capital expenditures (capex) for this year while the country is battling the coronavirus pandemic.

During its virtual stockholders' meeting, Emperador President Winston Co said the brandy maker would resume its "normal level of reinvestment" when things improve, as it did not want to underspend and risk affecting their delivery of results in the future.

Amount of the capex was not disclosed. The company is yet to reply to repeated requests for figures as of press time.
