

Emperador's Revenues Higher by 16% in the First Quarter of 2015

Emperador Inc., the Philippines' largest liquor company, recorded about P8.9 billion in revenues in the first three months of 2015, a 16 percent increase from P7.7 billion in the same period of last year. Emperador posted a net income of P1.4 billion during the first quarter of this year.

Emperador President Winston Co said, "The increase in liquor tax at the beginning of 2015 put some pressure on our margin. But these first few months have been busy for us. During the first quarter of this year, we opened our very first Emperador boutique at the Ninoy Aquino International Airport (NAIA) terminal 3 where we exclusively sell Emperador Deluxe Special Reserve brandy. And just last month we launched Smirnoff Mule, catering to a new consumer class looking beyond the common fare. Consumer response is positive and exciting."

Emperador disclosed earlier that it would be launching 8 major liquor products in the Philippines to cover all segments and categories in the market and that 2015 would be its busiest and most exciting year.
