Further to the disclosures on 03 December 2021, 28 February 2022, 16 May 2022 and 02 August 2022 of Emperor Inc. (the "Company"), please be informed that on 11 November 2022, the Conversion Period, was further extended from 12 November 2022 to 12 August 2023 (or such other date as may be mutually agreed in writing between the Securities Holder and the Issuer).

On 03 December 2021, the Company was given a period until 28 February 2022 ("Conversion Period") to issue Four Hundred Seventy-Five Million (475,000,000) ELS Shares to Arran Investment PTE Ltd ("Arran") per the Equity-Linked Securities ("ELS") Instrument. On 28 February 2022, the Conversion Period was modified from 28 February 2022 to 15 May 2022. On 13 May 2022, the Conversion Period was further modified from 15 May 2022 to 12 August 2022. On 02 August 2022, the Conversion Period was further modified from 12 August 2022 to 12 November 2022. On 11 November 2022, the Conversion Period was further modified as stated above.

The ELS was issued on 04 December 2014 to Arran as part of its investment in the Company.
